

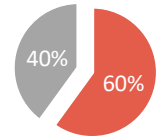
Investment Objective & Process

The objective of the 8AM AQ Global 60 portfolio is to deliver long term capital growth via fixed exposure to 60% global equities.

In addition, the aim of the 8AM AQ MPS is to deliver consistent outperformance of industry benchmarks, within pre-defined risk parameters. Our quantitative fund screening helps to identify managers delivering outperformance and holds these positions until relative performance declines or a superior choice becomes available.

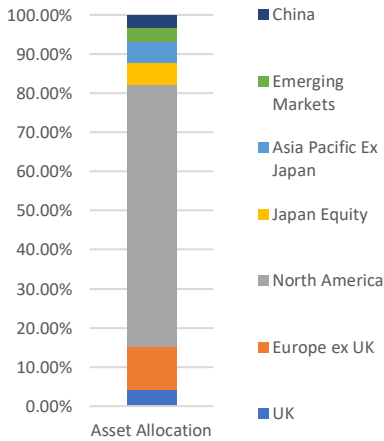

Equity Allocation

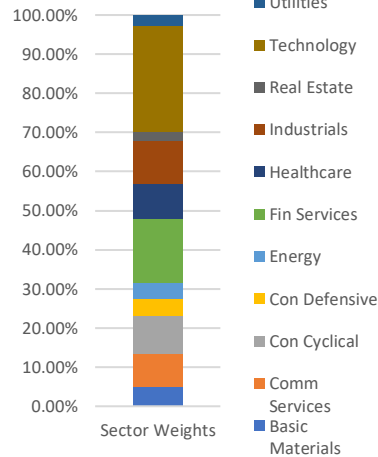

AQ Global Equity Geographic



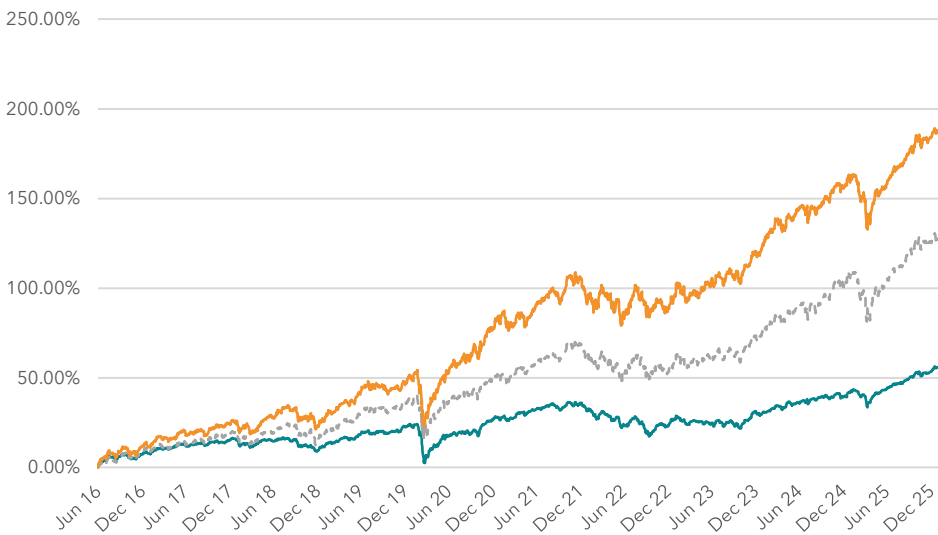
AQ Global Equity Sector
